IMPORTANT INFORMATION

Rehearsal & Rehearsal Dinner

- One camera coverage is usually adequate, unless you plan on extensive toasting. In that case, two camera coverage is recommended.

Pre-Ceremony I

- One or two cameras capture last minute preparations of the Bride and Groom. This coverage occurs at the ceremony location only.

Pre-Ceremony II

- Two cameras follow the couple the entire wedding day!
- Highly recommended for couples who have extensive pre-ceremony activities!

Ceremony & Reception

- Wireless mics/pro audio are not available on one-camera event coverage.
- Multi-camera coverage includes a wireless mic/pro audio.
- For single camera coverage, the edited ceremony may be abbreviated.
- More cameras allows us to produce a better product for you!

Photo Slide Show (placed on final DVD)

- Up to 100 pictures total.
- Scan your photos at 300dpi (sizes > 4x6) or 600dpi (sizes < 4x6).
- Save your photos in JPG format and provide them to us on a CD.
- Please provide 3 musical selections in WAV or MP3 format on a CD.

Travel

- For weddings 45 miles outside Decatur, Alabama or Nashville, Tennessee, over night lodging may be required. A fee of \$100 per day may be added to the final project cost to cover lodging. Travel fees and details will be discussed and finalized prior to the wedding day.

Final Delivery

- 3 complimentary DVDs are included with your order. Additional copies are available for purchase.
- All videos are provided to you in a standard size DVD case, complete with custom covers, labels, and DVD menu system.
- You will receive all the original miniDV footage at no extra charge.

Please read the following terms and conditions.

1. A 50% non-refundable retainer fee is required at time of booking to guarantee our availability on your date. The remaining balance is due 7 days prior to the wedding ceremony. Failure to pay the full balance prior to the event will cancel the booking and forfeit the retainer fee.
2. Retainer fees are not refundable.
3. Any footage to be emphasized or omitted must be expressed to the video crew during time of shooting and in writing within 3 days after ceremony (email is acceptable). Look Mom Videos will exercise best efforts to film and edit the footage as professionally as possible under contracted terms.
4. All videos are subject to be used as a demo and you can be used as a reference.
5. Look Mom Videos makes no guarantees, either expressed or implied, in regard to the aesthetic or stylistic qualities of the completed video.
6. Look Mom Videos uses existing light for all footage. Look Mom Videos will not be responsible for dark video footage due to dim lighting conditions at the location of wedding events.
7. Look Mom Videos will be on site approximately 1 hour before the ceremony. Other arrangements can only be made if specifically requested in this Agreement.
8. The wedding party, prior to the ceremony, must verify permission to film on location. Look Mom Videos will not be responsible for unwanted shooting angles due to venue rules.
9. Look Mom Videos must be provided, in typed print, all names that will be in the video credits prior to the wedding ceremony. Look Mom Videos is only responsible for the proper spelling of the material given. If the list of names given contains spelling errors, Look Mom Videos will only correct the errors for the editing rate of \$50.00 per ½ hour.
10. Any re-edits of final product due to error of Look Mom Videos will be done free of charge. Any re-edits of final product not due to error of Look Mom Videos will be done at a rate of \$50.00 per ½ hour.
11. Edited footage may be reduced such that it is not shown in real-time.
12. There is a possibility of camera failure and loss of footage leading to an incomplete video. In case of such failure, Look Mom Videos will use best efforts to edit the video.
13. Look Mom Videos takes utmost care with respect to the exposure, editing, duplication, and delivery of the video products and services offered. However, in the event that Look Mom Videos fails to comply with the terms of this Agreement due to any event or act outside the control of Look Mom Videos, Look Mom Videos' liability is limited to the refund of the total video price, less the retainer fee.
14. If any provision of this Agreement is held unenforceable, then such provision will be modified to reflect the parties' intention. All remaining provisions of this Agreement shall remain in full force and effect.
15. In the event of litigation relating to the subject matter of this Agreement, the non-prevailing party shall reimburse the prevailing party for all reasonable attorney fees and any resulting costs.
16. Look Mom Videos' principal place of business is in Decatur, Alabama. This agreement shall be interpreted under the laws of the State of Alabama.
17. This Agreement and the exhibits attached hereto contain the entire agreement of the parties with respect to the subject matter of this Agreement, and supersede all prior negotiations, agreements and understandings with respect thereto. This Agreement may only be amended by a written document duly executed by all parties.

I have been informed and understand that Look Mom Videos is producing a videotape program and that my name, likeness, image, voice, appearance and performance is being recorded and made a part of that production.

1. I grant Look Mom Videos and its designees the right to use my name, likeness, image, voice, appearance, and performance as embodied in the video whether recorded on or transferred to videotape, film, slides, photographs, audiotapes, or other media, now known or later developed. This grant includes, without limitation, the right to edit, mix, or duplicate and to use or re-use the video in whole or in part as Look Mom Videos may elect. Look Mom Videos or its designee shall have complete ownership of the video in which I appear, including copyright interests, and I acknowledge that I have no interest or ownership in the video or its copyright.
2. I also grant Look Mom Videos and its designees the right to broadcast, exhibit, market, sell, and otherwise distribute the video, either in whole or in part, and either alone or with other products, for commercial or non-commercial television or theater, closed-circuit exhibition, home video distribution or any other purpose that Look Mom Videos or its designees in their sole discretion may determine. This grant includes the right to use the video for promoting or publicizing any of the uses.

I confirm that I have the right to enter into this Agreement, that I am not restricted by any commitments to third parties, and that Look Mom Videos has no financial commitment or obligations to me as a result of this Agreement. I hereby give all clearances, copyright and otherwise, for the use of my name, likeness, image voice, appearance and performance embodied in the video. I expressly release and indemnify Look Mom Videos and its officers, employees, agents and designees from any and all claims, known and unknown, arising out of or in any way connected with the above granted uses and representations. The rights granted Producer herein are perpetual and worldwide.
4. In consideration of all of the above, I hereby acknowledge receipt of reasonable and fair consideration from Look Mom Videos for the services provided.
